Proposed Constitutional Amendment: Question 1

Propuesta de enmienda constitucional: Pregunta 1

Question: Should the Constitution of Virginia be amended to (i) protect the freedom to make personal decisions about prenatal care, childbirth, postpartum care, birth control, abortion, miscarriage management, and fertility care; (ii) protect doctors, nurses, and patients from being punished for these decisions; and (iii) allow for restrictions on access to abortion during the third trimester of pregnancy except when the patient's health is at risk or the pregnancy cannot survive?

Pregunta: ¿Debe enmendarse la Constitución de Virginia para: (i) proteger la libertad de tomar decisiones personales sobre la atención prenatal, el parto, la atención posparto, los métodos anticonceptivos, el aborto, el tratamiento de un aborto espontáneo y la atención de fertilidad; (ii) proteger a médicos, enfermeros y pacientes para que no sean sancionados por tomar estas decisiones; y (iii) permitir restricciones al acceso al aborto durante el tercer trimestre del embarazo, excepto cuando la salud de la paciente esté en riesgo o el embarazo no sea viable?

Propuesta de enmienda constitucional: Pregunta 2

Question: Should the Constitution of Virginia be amended to (i) remove the ban on same-sex marriage; (ii) affirm that two adults may marry regardless of sex, gender, or race; and (iii) require all legally valid marriages to be treated equally under the law?

Proposed Constitutional Amendment: Question 3

Propuesta de enmienda constitucional: Pregunta 3

Question: Should the Constitution of Virginia be amended (i) to provide for the fundamental right to vote in the Commonwealth, (ii) to revise the qualifications of voters so that a person convicted of a felony is not entitled to vote during his period of incarceration but is automatically invested with the right to vote upon release from incarceration, and (iii) to update the existing prohibition on voting by persons found to be mentally incompetent to instead apply to persons who have been found to lack the capacity to understand the act of voting?

Pregunta: ¿Debe enmendarse la Constitución de Virginia para: (i) establecer el derecho fundamental al voto en el estado de Virginia; (ii) modificar las cualificaciones de los votantes, de modo que una persona condenada por un delito grave no tenga derecho a votar mientras esté encarcelada, pero recupere ese derecho de manera automática al ser liberada; y (iii) actualizar la prohibición vigente sobre el voto para personas declaradas incapaces mentales, de manera que se aplique en su lugar a las personas que hayan sido declaradas incapaces de comprender el acto de votar?
